Sustainability at corporate level, social responsibility and fair treatment of business partners are part of our corporate culture. Through our business activities we influence the living and working conditions of our employees, our customers, the environment and the economic environment.

In order to meet our corporate responsibility in these areas, we follow the principles and goals specified here. They are based on the ten principles of the United Nations Global Compact Initiative, the United Nations Guiding Principles on Business and Human Rights and the International Labor Organization Declaration on Fundamental Principles and Rights at Work.

As our supplier, we expect you to recognize, support and comply with the following principles and objectives and to ensure that your suppliers also comply with them.

Sustainability and environmental protection

You are committed to protecting the environment and to sustainable and responsible corporate management and development. In particular we expect from you:

- You comply with all applicable environmental, health and safety regulations.
- You strive for the most effective and efficient use of materials, energy and water and use energy-efficient and environmentally friendly technologies to conserve natural resources.
- Waste avoidance is a basic principle of your processes.
- Your practices should comply with the principles of the circular economy, such as material reduction and substitution, as well as return, shared use, maintenance, reuse, remarketing, remanufacturing, reconditioning, and recycling.
- You ensure the safeguarding of soil quality. Soil contamination must be avoided at any rate.
- You minimize all environmental effects, especially waste, wastewater, air and noise pollution, but also those of logistics and transport and storage.
- When handling chemicals and hazardous substances, you minimize negative effects on the
 environment and health and save resources in the best possible way. You stand for
 responsible chemical management.
- You meet the applicable requirements on product quality and product safety by means of suitable management systems.
- You protect the life and health of your employees and all third parties against the hazards that can arise from your manufacturing processes and products.
- You minimize the impact of your activities on biodiversity, climate change (especially
 greenhouse gas emissions) as well as water scarcity and quality, including the
 protection of animals and plants.
- You reduce greenhouse gas emissions and support decarbonization. One goal here is to pursue minimal or zero CO2 emissions as far as possible.

Business ethics and social responsibility

- a salary that enables the securing of existence and social and cultural participation,
- ensuring equal opportunities and family-friendly conditions, as well as,
- women's rights according to EU Issue Paper No. 26,
- the prohibition of bribery and extortion,
- the prevention of corruption and bribery,
- compliance with applicable laws and regulations, such as applicable data protection regulations,
- the deployment of private and public security forces must be carried out in compliance with the legal framework conditions,
- Ensuring intellectual property and trustworthy handling of information and data provided in compliance with property rights and copyrights,
- the commitment to implement measures within your area of responsibility to
 ensure that neither customer products nor their workable components or raw
 materials or corresponding know-how fall into the hands of counterfeiters and
 smugglers or other unauthorized third parties or leave the legitimate supply chain
 as plagiarized products,
- ensuring fair competition in compliance with antitrust law,
- the compliance with the applicable rules on the disclosure of information,
- the fulfilment of financial responsibility,
- the avoidance of conflicts of interest,
- Compliance with foreign trade regulations, insofar as this lies within the scope of your responsibility. In this context, national and international economic sanctions as well as export control regulations are observed. You undertake to provide correct and truthful information about this to customs and other authorities as required.
